



**MINUTES
WEST GREY POLICE SERVICES BOARD
MONDAY, SEPTEMBER 29, 2025**

A meeting of the West Grey Police Service Board was held Monday, September 29, 2025 in the Committee Room at West Grey Municipal Office. This meeting was to replace the September 8th meeting which was cancelled due to lack of quorum.

Chair Fawcett welcomed member John Bell who has completed the mandatory Roles and Responsibilities training and who was sworn in prior to the start of the meeting.

The meeting was called to order at 9:00 a.m.

Business Arising From The Minutes

No items brought forward for discussion.

Monthly Stats

July and August stats were presented by Chief White.

Chief White advised the members that 911 hang ups had increased with the year to date total being 287 for August. This is due in part to the fact that members of the public use this line as a means to communicate with Police rather than looking up business line number for non-emergent calls.

Mental Health calls continue to constantly be on the rise and represent a significant portion of calls for service .

Over the last two months the Service has logged seven(7) calls for Police Assistance-Outside West Grey.

Unwanted Person calls for July and August numbered 17 and relate to homeless persons using public spaces to sleep, etc. Offers by Officers to assist in obtaining emergency housing or getting them in touch with organizations willing to assist with other matters is often turned down.

Provincial Offences Act charges numbered 79 in July and 107 in August. Number of arrests are down but charges are up due to individuals incurring long list of charges per individual call.

Chief's Report

- no secondary employment requests received
- no LECA complaints
- no SIU complaints
- currently seeking applications for one recruit for start of 2026
- at present two officers remain off duty on WSIB claims with no updates from WSIB
- Acting Deputy Chief Iles recently completed Rapid Deployment Training
- new building update from Chief Building Official has project on target for end of November early December completion
- Community Events attended by Chief included Durham Loves Canada Event July 1st, meeting at upper dam pavilion regarding SVCA fencing of portions of Conservation Area, Durham B.I.A. Sunfest, Durham Fall Fair, Family Ball Tournament in Ayton.
- Service was busy over the August long weekend issuing 44 provincial offences(speeding) tickets.
- Chief White made the members aware of several significant calls the Service had responded to in the past two months ranging from break and enters, attempted murder, and attempted escape from cruiser while in transit.
